Structure

Total of 11 Directorates have been established for the Secretariat.

Of these Directorates, 3 Directorates function to serve the Wolesi Jirga, 3 Directorates function to serve the Mashrano Jirga and the remaining 5 Directorates function to serve both the Houses.

Recruitment

250 staff have already been recruited from among 800 applicants through open competition based on merits and qualifications.

Another 85 security personnel have also been recruited.

Training

All the staff that have been recruited have followed training programmes conducted for them in Kabul.

Experts from overseas have travelled to Kabul to conduct these training programmes.

More than 170 of staff have been sent to countries such as Italy, Sri Lanka, India, Indonesia, Turkey, Netherlands, Germany and France to learn about parliamentary processes and best practices. These study tours will continue in future as well.

A National Seminar is being held for staff on parliamentary processes and best practices.

Budget

46 million Afghanis have been acquired by the Secretary only for renovation purposes and this amount is not to meet the logistic requirements of the National Assembly.

Professional Preparations

The Internal Regulation for the National Assembly has been prepared. Resources and References used were:

- Research and studies carried out by different parliamentary institutions
- Documents from the Constitutional Monarchy period in Afghanistan and documents from previous National Assemblies in Afghanistan
- Internal Regulations from other Parliaments of the world
- International Experts

Regulation for the staff of the Secretariat has been put together.

This Regulation has been drawn up keeping in consideration the existing regulations for government officials and the needs of the National Assembly. Conditions for fellowship and scholarships have been laid down.

- Security of Parliament Sessions
